Please read carefully before signing. Each driver should also initial beside each paragraph. In consideration for the use of the ebike, I agree to the following conditions.

1. I acknowledge this Ebike is to be rented the entire time of my vacation rental, like the golf cart or renting a car.
2. I acknowledge that I am 100% responsible for any injuries or damage caused by me from the rental of this eBike.
3. I promise to return the ebike to the location picked up immediately upon completion of the rental period in as good condition as I received the same, normal wear and tear excepted. I will operate the ebike safely and responsibly, and I will preserve and protect the ebike from loss or damage to the bike itself, my person or property, and the persons or property of others. I will lock up the bike around a concrete or solid post if shopping.
4. I agree to hold harmless, defend, and indemnify Carolyn Hodgson, and/or any other affiliates and/or family members for any and all damages and claims of any nature whatsoever, whether or not foreseeable, that may arise from the use of said ebike during the term of the rental period or of my possession of the ebike, including but not limited to claims for damages to the ebike itself, my person and property, and the persons and property of others. I agree to waive all right to seek redress against Carolyn Hodgson and/or any other affiliates and/or family members. I further agree to waive my right, if any, to punitive damages.
5. I agree that only drivers who are listed on the Rental Application and who have signed this Binding Fusion eBike Rental Agreement and Waiver may operate the ebike. I understand that there are no exceptions, and I am responsible for enforcing this rule.
6. I agree to become familiar with the operation and use of said ebike, I agree to contact Carolyn Hodgson and or manager, if I have any questions or concerns about operating the ebike. I further agree to contact Carolyn Hodgson and/or manager if any damage occurs to the ebike or to other persons or property through the use of the ebike. I agree to examine and inspect the safety and mechanical condition of the ebike, reporting any concerns or problems before driving it. Including but not limited to the requirement that persons driving the ebike must not be under the influence of alcohol and/or drugs.
7. I further agree that I will operate the ebike only on the bike path shoulder. I understand that ebikes shall not be driven down the center of the street. I agree that the ebike shall not be operated after sunset. I further agree that I personally will be responsible for all moving and/or parking violations issued to said cart while it is in my possession, under my control, or at any time during the rental period.
8. I understand that if the ebike should become inoperable through no fault of mine, Carolyn Hodgson, owner and/or property manager, will take reasonable steps to have it repaired.
